NASTAR

I acknowledge that participating in NASTAR events ("Event"), skiing in general, and ski racing, involves a RISK OF PERSONAL INJURY to me and damage to my property, and I knowingly and voluntarily agree to the terms and conditions outlined in this Waiver and Release of Liability. In exchange for being permitted to participate in the Event, I agree to the following:

I am in good health and have no physical conditions that affect my ability to participate in the Event and have not been advised otherwise by a medical practitioner. I agree that before I participate in any portion of Event, I will inspect the related facilities, competition site, and equipment. I will immediately advise Event personnel of any unsafe condition that I observe. I will refuse to participate in any activity related to the Event until all unsafe conditions have been remedied.

I ASSUME ALL RISKS associated with my involvement with the Event, skiing, and ski racing, and the risk of injury caused by the condition of any property, facilities, or equipment used during the Event, and at the hosting ski area, which may not be reasonably foreseeable by anyone at any time. I agree not to sue NASTAR, the United States Ski and Snowboard Association ("USSA"), the applicable sponsoring/hosting ski area where the Event is held, and the Event sponsors, along with their parent companies, affiliates, and their successors, assigns (collectively referred to hereinafter as "Companies"), their respective employees, agents, or other volunteers, and insurers of any of the above for any injuries, losses, damages, claims, liabilities, or expenses that are caused or alleged to be caused by their negligent or reckless acts or omissions, hazards that are normally associated with participating in the Event, or the condition of the property, facilities, or equipment used for the Event or at the hosting ski area.

I agree to indemnify, defend, and hold harmless Companies and their employees, agents, volunteers, and insurers of any of the above from and against any claims, causes of action, damages, judgments, liabilities, fees (including attorney's fees), costs, and expenses incurred by Companies as a result of my unlawful actions or failure to act during the Event, or while using any of the trails or facilities at the hosting ski area.

I give permission for Companies to use my biography, name, and likeness in connection with the Event, and any publicity, advertising, and promotion for the Event and future editions of the Event. I waive any right that I may have to inspect or approve any finished product that may be used in connection with the Event. I assign to Companies all rights I may have to my biography, appearance, name, voice, photo, video, or film likeness that have been recorded in connection with the Event.

I agree to wear appropriate safety equipment as established by common safety practices during all activities at the Event and while using any of the trails or facilities at the hosting ski area. In connection with any injury or other medical conditions I may experience during the Event or while using any of the trails or facilities at the hosting ski area, I hereby consent to receive medical treatment deemed necessary by medical personnel if I am not able to act on my own behalf. I agree not to sue any applicable medical practitioners who may provide medical treatment to me for malpractice. This Waiver is a legally binding agreement which will remain in full force and effect at any time during my participation in the Event and while using any of the trails or facilities at the hosting ski area and will be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. Any provisions found to be void or unenforceable shall be severed from this agreement, and not affect the validity or enforceability of any other provisions. This Agreement will be construed pursuant to the laws of the State of Colorado and I agree not to contest this choice of laws provision in any legal action.

I have read this document and I understand its content. I understand that by signing below, I have given up substantial rights. I have voluntarily signed this release.

SEASON PASSES

1. I acknowledge that skiing/snowboarding is hazardous and that there are many inherent risks in these sports, including but not limited to variations in terrain, surface and subsurface snow, ice conditions, moguls, bare spots, forest growth, rocks and debris, lift towers and other obstacles and hazards. I acknowledge that snowmaking and snow grooming may be in progress at any time.
2. I have read and will obey the guidelines issued under the RESPONSIBILITY CODE as found on the Wachusett trail map and website. I agree to ski/ride in control and with care at all times.
3. In consideration for my or my child's use of the equipment or the resort facility, I agree, for myself and/or my child, to RELEASE, forever indemnify, defend, and hold harmless Wachusett Mountain Associates, Inc. & their owners, officers, directors, volunteers, employees, affiliates, agents and assigns, (collectively as "RELEASEES") from liability for any and all loss or damage to myself or to my child or my or my child's property resulting from the RELEASEES' NEGLIGENCE or any other cause. I understand that the RELEASEES are not responsible for the consequences of their own NEGLIGENCE, that is, their failure to use reasonable care in any way. I acknowledge that I am freely and expressly assuming and accepting any and all risks of property damage, personal injury and death in connection with my or my child's use of the resort, use of the rental equipment, and participation in skiing/snowboarding including instructional lessons. For parents/guardians of participants of minority age (under Age 18 at time of registration) this is to certify that I individually or as parent/guardian signing this agreement for the named minor, acknowledge and agree that I have read the above release of liability and that by signing this release on behalf of the minor.
4. This pass is for your personal use only. Transferring, improper use of this pass, or falsification of age will result in loss of privileges. I understand that I may use my season pass only during times valid. Failure to adhere to this policy is considered theft of service.
5. The season pass is the property of Wachusett Mountain Associates, Inc. and is revocable, without refund, due to misconduct or misuse as determined by Wachusett Mountain Associates, Inc. personnel.
6. There are no refunds for missed sessions due to weather or mechanical difficulties. There are no credits or refunds due to failure to pick up a season pass that has been pre-purchased. Season Pass Insurance (must be purchased when pass is ordered) provides pass replacement or pro-rated refund if pass cannot be used due to job, injury, illness or move. Any issues regarding the current season must be presented in writing no later than April 1st. NOTE: Insurance does not apply to Terrain Park Pass.
7. Night operating schedule may be limited during early or late season.
8. Season Pass does not guarantee admission during sellout periods. Limited Ticket Sale Policy: We strive to provide a quality skiing and snowboarding experience by limiting the number of tickets sold.
9. If a season pass is forgotten, pass holder will be required to purchase a fullrate lift ticket. Lost season pass replacement fee is \$15 without purchase of Pass Insurance. Return check fee \$25.

10. If renting equipment, I also agree that the same set of equipment will not be issued each visit and that the ski-boot-binding system will not release at all times or under all circumstances.
11. I agree that this agreement will be governed by Massachusetts law. I also understand that if any part of this agreement is determined to be unenforceable, all other parts shall be given full force & effect. I agree & understand that any claim or lawsuit against the RELEASEES may be brought in the federal or state courts of Massachusetts only.

SNOW SPORTS EVENTS/ NIGHT LEAGUE RACING

I am aware that the EVENT in which I am participating or plan to participate under the sponsorship or arrangement of Wachusett Mountain Associates and all other sponsors and affiliates, is a HAZARDOUS ACTIVITY which is inherently dangerous. The participant has voluntarily entered the event despite all known and unknown risk of personal injury and/or death presented by participating for and/or actual participation in the event; and Participant understands that this Agreement is a general release barring Participant from bringing any claim for personal injury and/or death which is any way related to participating for and/or participating in the scheduled event; and, In exchange for the right to participate in the competition and the services of the above-mentioned Wachusett Mountain, the participant expressly and freely agrees as follows:

1. To ASSUME ALL RISK of serious personal injury and/or death arising from practicing and/or participating in the scheduled event.
2. To WAIVE any and all claims that the participant may in the future have against Wachusett Mountain Associates, Inc. and any other participating sponsors, their officers, employees, directors, shareholders, affiliated entities, subsidiaries, all insurers, for any and all loss, damage, injury or express that Participant may suffer, or that Participants next of kin may suffer, as a result of Participant's practicing for and/or participation in the scheduled event, due to any cause whatsoever, including but not limited to negligence on the part of Wachusett Mountain Associates, Inc. and any other participating sponsors, their officers, employees, directors, shareholders, affiliated entities, subsidiaries, all insurers, any entity or person hired to perform any function.
3. To RELEASE FROM LIABILITY AND HOLD HARMLESS Wachusett Mountain Associates, Inc. and any other participating sponsors, their officers, employees, directors, shareholders, affiliated entities, subsidiaries, all insurers for any and all loss, damage, injury or express that Participant may suffer, or that Participants next of kin may suffer, as a result of Participant's practicing for and/or participation in the scheduled event, due to any cause whatsoever, including but not limited to negligence on the part of Wachusett Mountain Associates, Inc. and any other participating sponsors, their officers, employees, directors, shareholders, affiliated entities, subsidiaries, all insurers, any entity or person hired to perform any function.
4. Wachusett Mountain Associates, Inc. and any other participating sponsors will have the irrevocable and perpetual right, but not the obligation, to use, as they may desire, all still and motion pictures and recordings that such entities may make of Participant or Participant's voice during any event that Participant practices for and/or participates in, including the right to use Participant's name, likeness and biographical information in connection with the advertising, publicizing, exhibiting and exploiting Wachusett Mountain Associates, Inc. and any other participating sponsors or such event(s), in whole or in part, in any manner whatsoever, by any and all means, media, devices, processes and technology now or hereafter known or devised in perpetuity throughout the universe

Participant agrees that any claim brought against Wachusett shall be submitted to the jurisdiction of the State or Federal Courts in the State of Massachusetts and in no other jurisdiction. Any claim brought shall be governed by the laws of the state in which the claim arose. I FURTHER RECOGNIZE THAT NO REPRESENTATIONS OR ASSURANCES ARE BEING MADE TO ME BY WACHUSETT MOUNTAIN ASSOCIATES OR THEIR AFFILIATES, AS TO MY PROFICIENCIES OR ABILITIES TO ENGAGE SAFELY IN THESE ACTIVITIES. The terms hereof shall bind my heirs, executors, administrators and assigns and shall serve as of assumption of risk and general release for all members of my family, including any minor children, participating in such activity.
